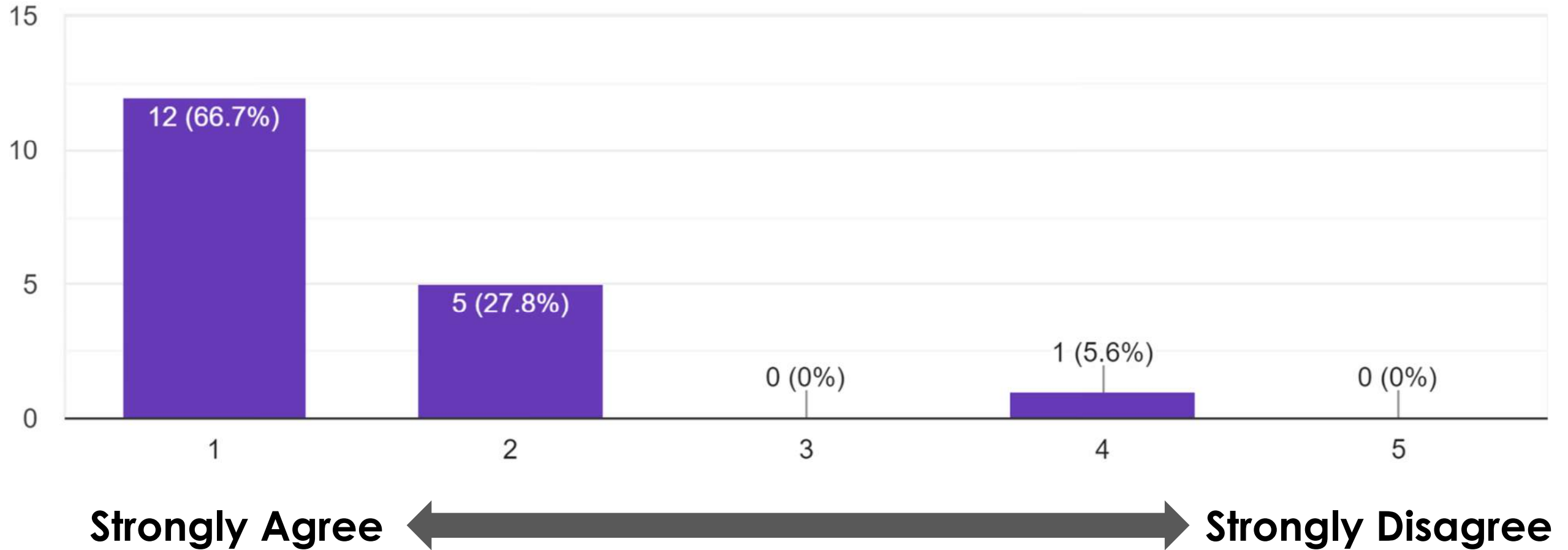

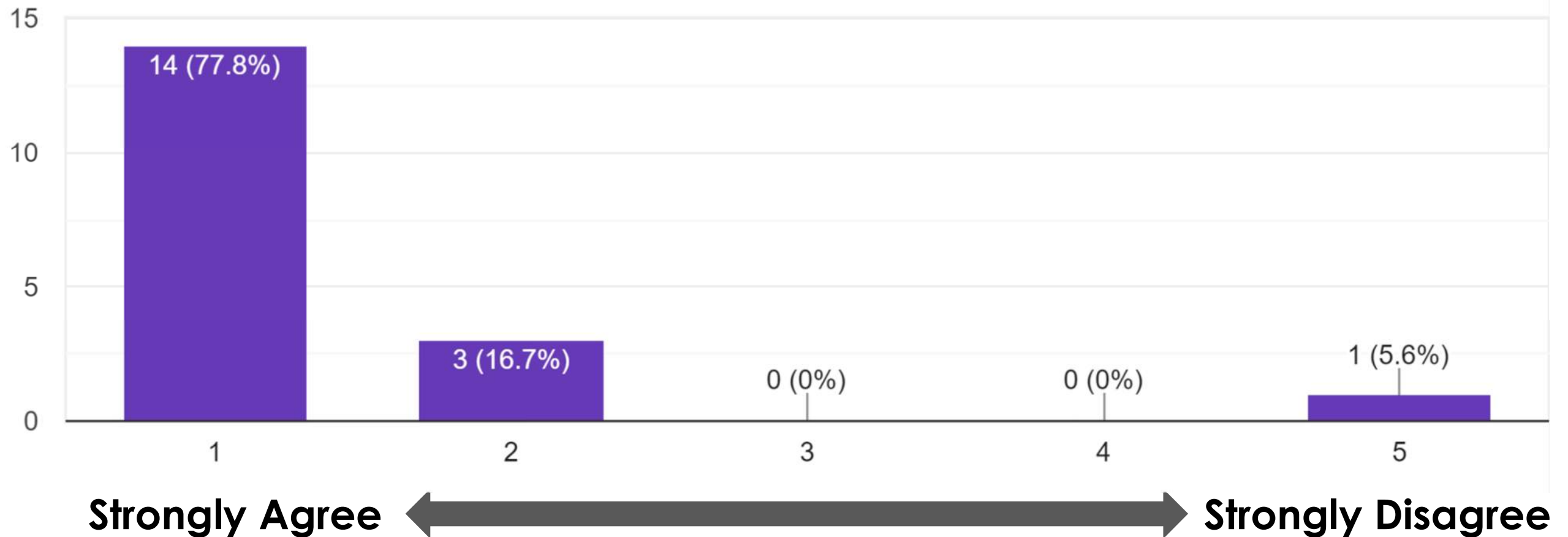

## 2. Information used and generated during the planning process is shared openly, publicly, and is easily accessible





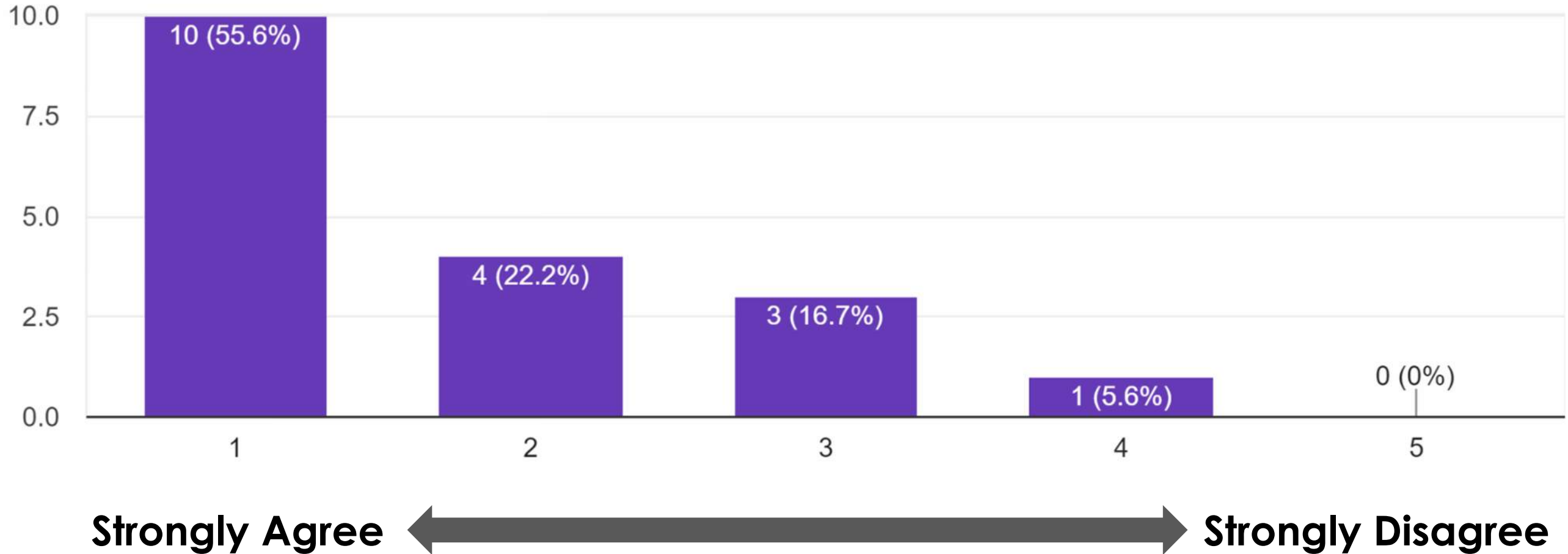

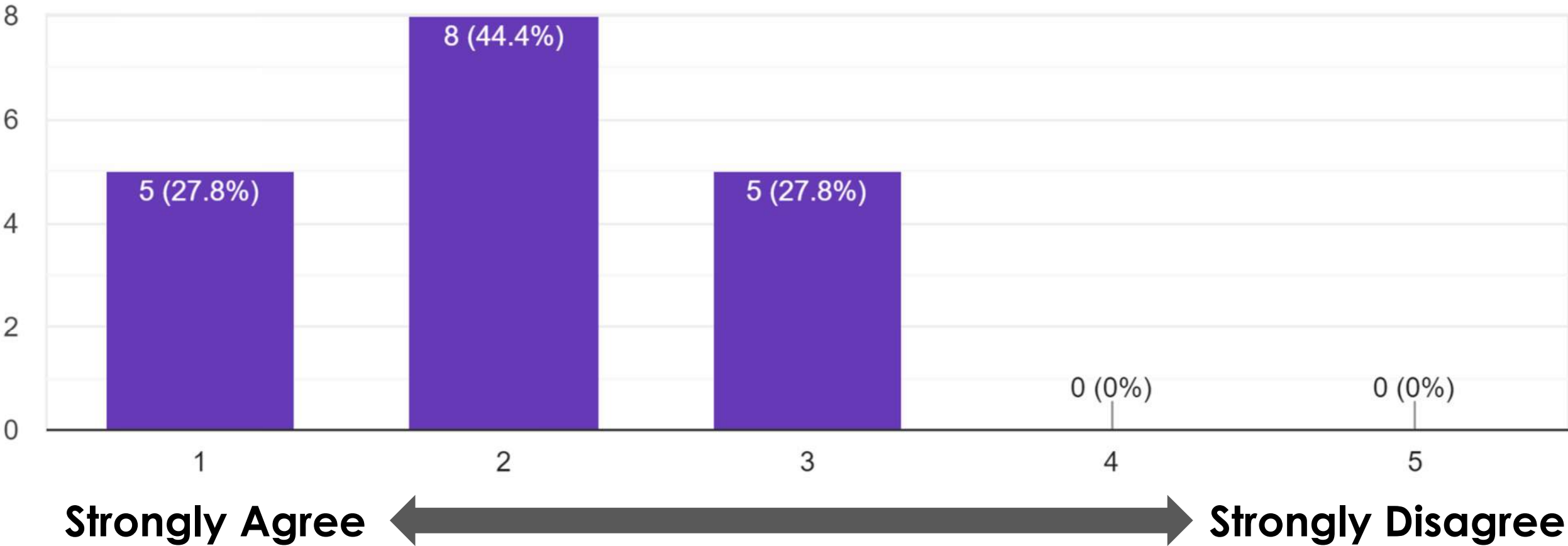
Need to cut down on the "why not" discussion that has nothing to do with putting a proposal on the table.

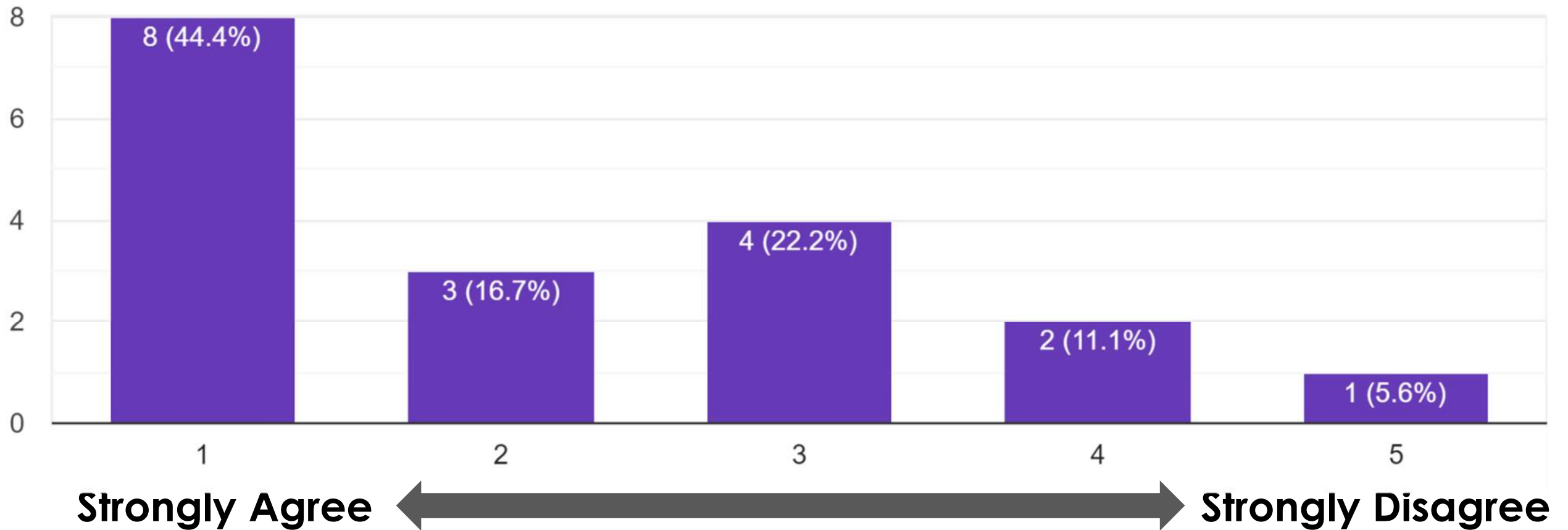
The technical info can be difficult to understand, but it is needed. The hard part will be management recommendations that will be acceptable to all.

Basin planning requires review and understanding of a lot of technical information. Based on some of the responses from the RBC members during meetings, earlier presented material was either not understood at that time or may not have been retained. Members may not fully understand all the technical information or how it may relate to their and other stakeholder interests.

A synopsis that is as simplified as possible sent out after the meeting could help explain the more scientific and/or difficult subjects. Similarly, a preview that is sent out several days to a week ahead of the upcoming meeting might be helpful.

Self study is essential, but that is not something the process can dictate. Also, paper copies of materials [would help].

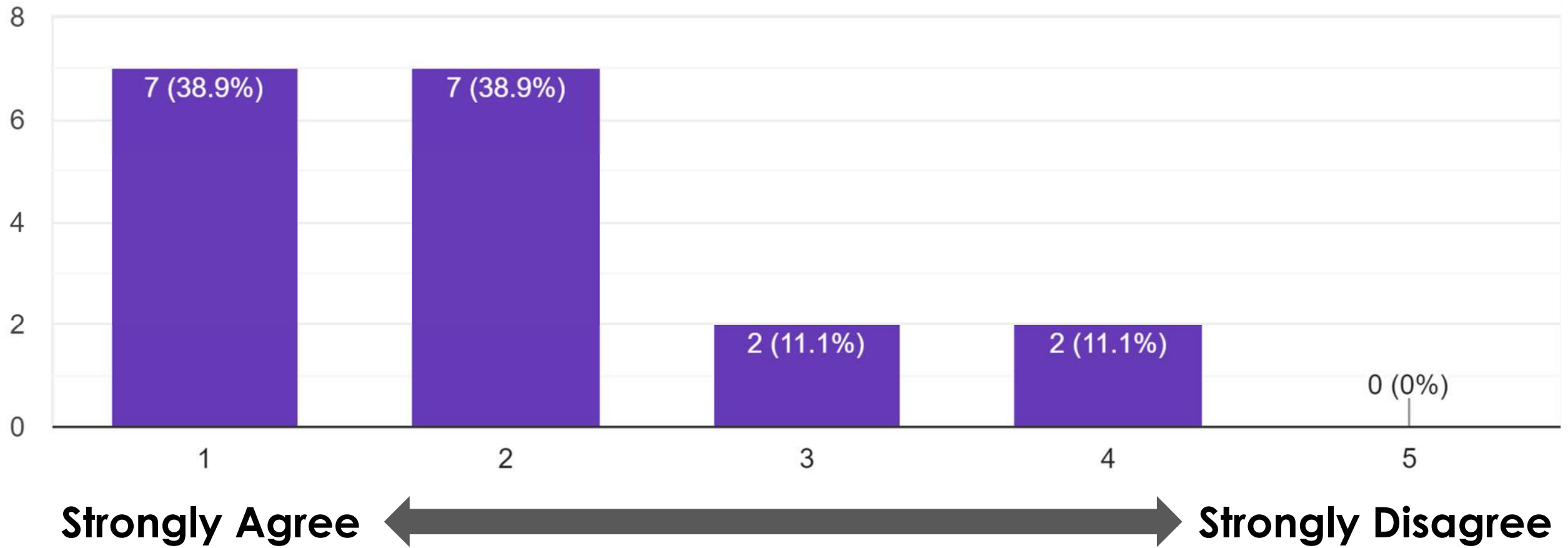
### **Responses**

## 6. Controversial issues are discussed openly in a respectful manner, and multiple options for resolution are considered.



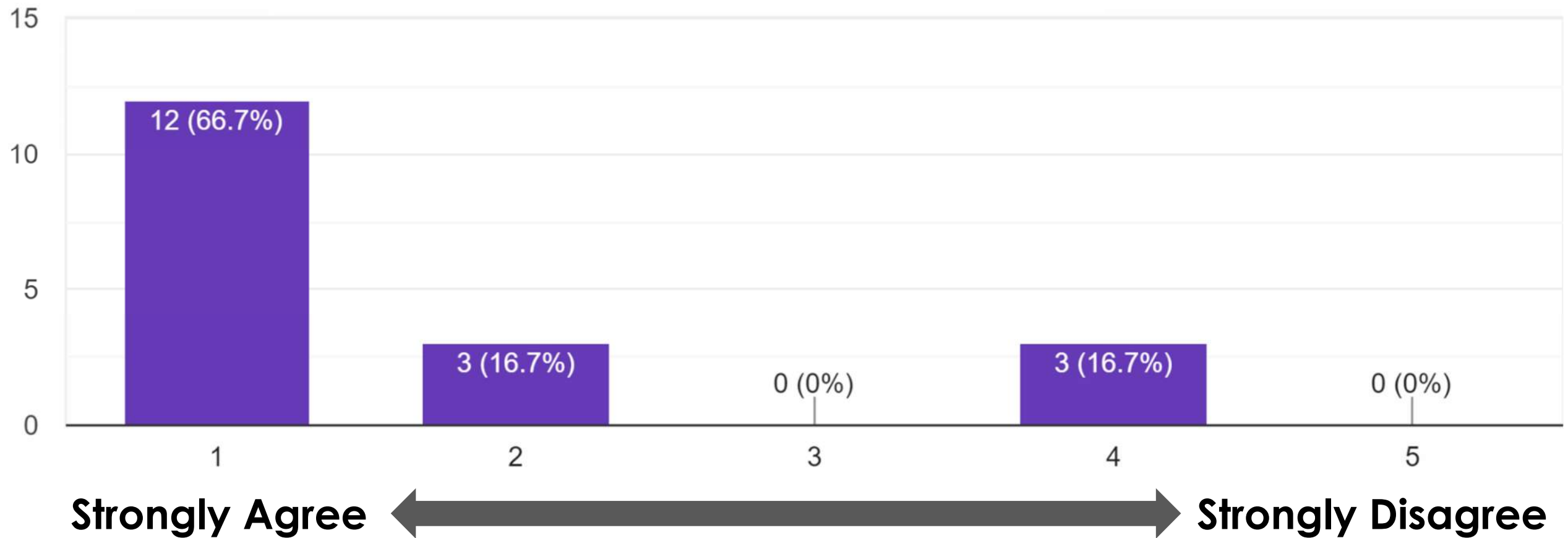


## **6. Controversial issues are discussed openly in a respectful manner, and multiple options for resolution are considered.**

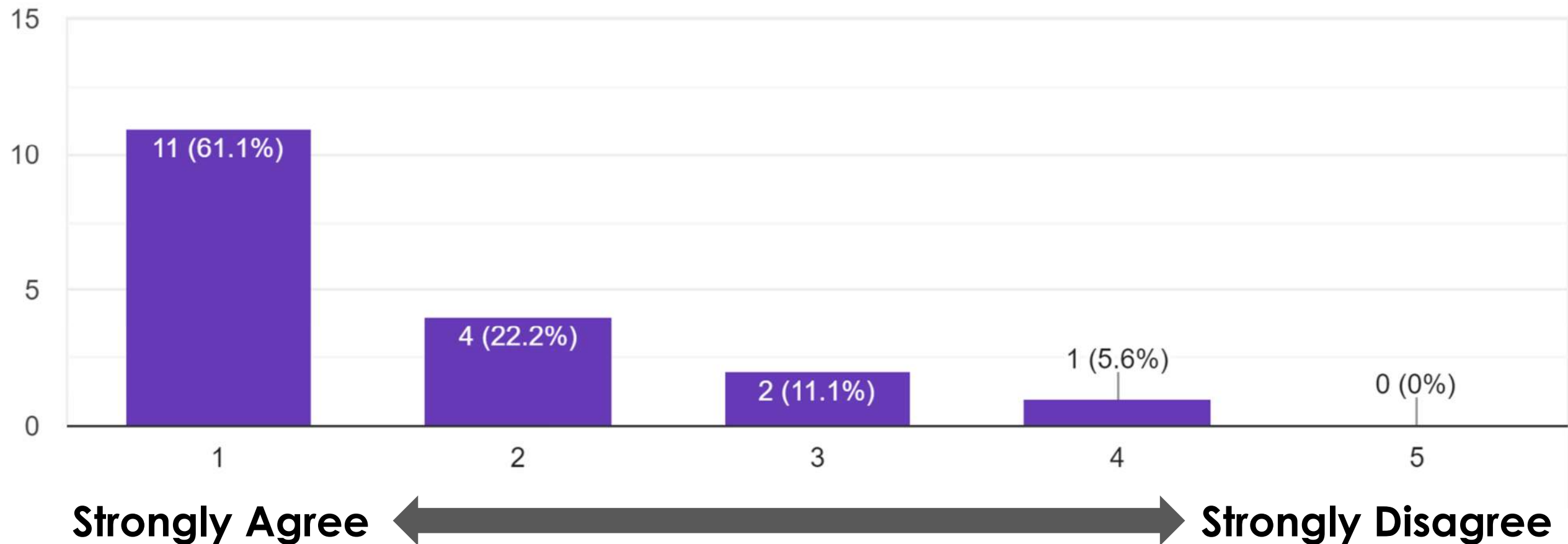

It is important to open a council such as the RBC with a prayer. More ethnic representation is needed.

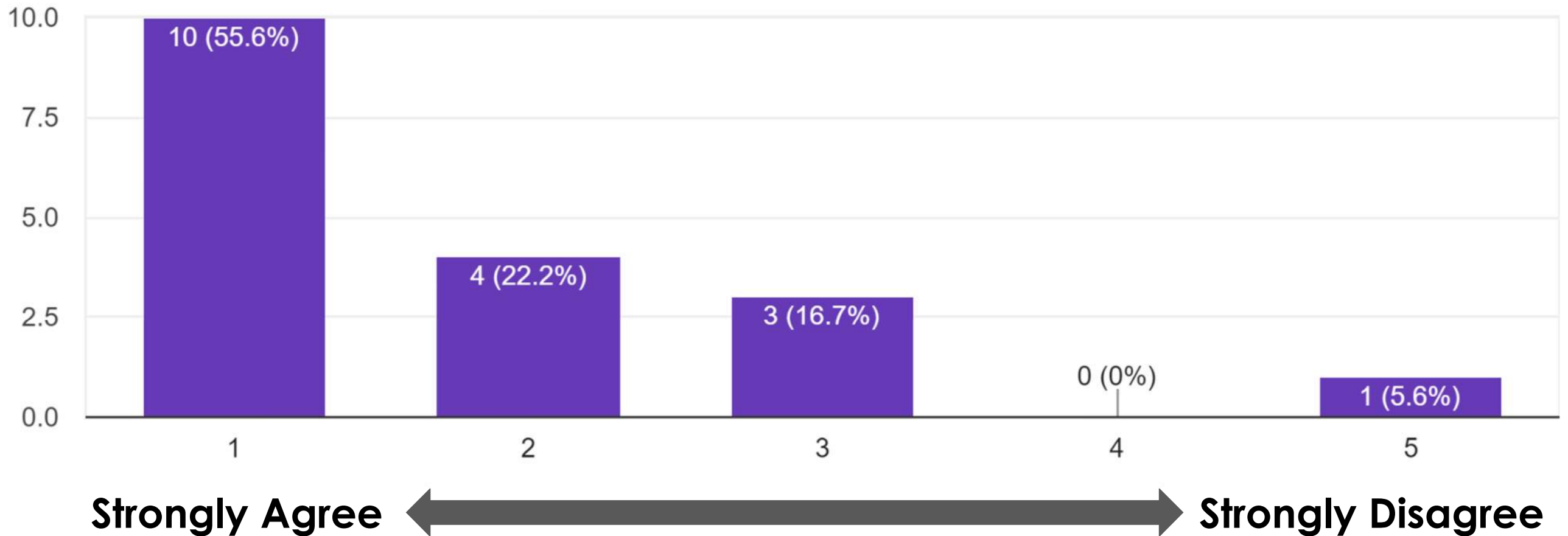
[Some members] don't take advantage of the opportunity to speak. Being more prepared for the meetings [may help]
