# *The State of South Carolina's 2000 §303(d) List of Priority Ranked Waterbodies Targeted for Water Quality Management Action*

---

## **1. Introduction**

The South Carolina Department of Health and Environmental Control (Department) developed this priority list of waterbodies pursuant to Section 303(d) of the Federal Clean Water Act (CWA) and Federal Regulation 40 CFR 130.7 and in compliance with the requirements of the current regulation. The list identifies South Carolina waterbodies not meeting State water quality standards after application of required controls for point and nonpoint source pollutants and priority waterbodies to which the Department can direct its attention when developing required controls. The severity of the pollution and the classified uses of the waterbodies were employed to determine the ranking of the list in conjunction with the Department's five-year rotating basin Watershed Water Quality Assessments (WWQA). The list will be used to target waterbodies for water quality protection plans and processes, including Total Maximum Daily Loads (TMDLs), for listed waterbodies.

The impacts of point sources to waterbodies have been substantially mitigated through assimilative capacity determinations which have been incorporated into National Pollutant Discharge Elimination System (NPDES) permits. Nonpoint source impacts have also been reduced exclusive of TMDL development or implementation through a combination of statutes and regulations (the SC Pollution Control Act, Water Quality Certification, and Sediment and Erosion Control Act), outreach and education initiatives undertaken by this Agency and other government entities, and voluntary landowner stewardship efforts (such as the National Resource Conservation Service's EQIP and Conservation Reserve Program). The continued expansion and promotion of these and other analogous programs in conjunction with TMDL development and implementation should lead to an effective combination in reducing point and nonpoint source pollution of waterbodies.

In compliance with 40 CFR 25.4(c), the Department issued a public notice in regional newspapers (January 28 and 29, 2000) to ensure statewide coverage of the Department's intent to update its list of impaired waterbodies and the prioritization of the list and targeting development of Total Maximum Daily Loads (TMDLs). The notice included a person to contact for information regarding the development of the list and asked for comments regarding the draft list, list methodology, priority ranking, and TMDL target dates. The notice allowed for a thirty day comment period in which to respond. The Department also mailed out a copy of the public notice to more than three hundred and sixty interested parties which included environmental groups, industries, private individuals, local governments, universities, research groups, other State agencies, and the EPA. The Department also posted the public notice and the draft list on its internet website to provide supplemental public notification and coverage. A copy of the notice of availability of the draft list is provided.

Additional public input is solicited during public workshops conducted in locations throughout each of the eight basins during development of its WWQAs. Since the 1998 listing cycle, the Department has held three workshops in two of the basins and has held numerous public meetings in other basins that included discussions of impaired waterbodies in the areas of concern. This increased participation of the public in the "§303(d) process" will continue in accordance with our watershed approach. The workshops and smaller meetings are held in part to obtain public input on the §303(d) prioritization process. In these meetings, Department staff solicit information regarding the South Carolina §303(d) list of impaired waterbodies and distribute handouts containing information about the list and its purpose. The information that staff receive at these meetings is integral to the discovery of some sources of pollution, including those on the impaired waterbodies list. Prior to holding these meetings, the Department mailed fliers to interested parties in the affected area. The information gathered at these meetings is included in the WWQAs and ultimately in the §303(d) list of impaired waterbodies for the State.

For this listing cycle, the Department actively solicited data and information for the specific purpose of §303(d) listing. The solicitation notice was published in an areawide newspaper and a copy of the notice was mailed to

the same mailing list used for the §303(d) public notice of drafting mentioned above. The Department also placed the solicitation notice on its internet website. A copy of the solicitation notice is provided.

In response to this solicitation notice, the Department received seven inquiries requesting further information regarding the type of data and information needed, the applicable requirements for quality assurance, and information specific to data on waterbodies and whether these waterbodies would be included on the 2000 §303(d) list. After initial discussions, the Department received data and information from two contributors which are included in the list of sources of data and information in section 3 of this document.

This document is organized into five sections and four attachments. This first section is the introduction which briefly describes the purpose for developing the list, how the list will be used, and public participation in its development and circulation. The second section describes the methodology for delisting waterbodies from the EPA-approved 1998 §303(d) list. The third section describes the methodology for identifying impaired waterbodies and developing the list which includes the sources of data and information used for the list. The fourth section describes the methodology used to prioritize the list. The last section describes the methodology for targeting specific waterbodies for TMDL development. The first attachment is the priority ranked list. We have also included a compilation of the delisted waterbodies from the 1998 §303(d) list. As mentioned earlier, a copy of the Department's solicitation notice for other data and information and a copy of the notice of availability of the list is included.

## **2. Methodology for Delisting Waterbodies from the 1998 §303(d) List**

The Department reviewed the 1998 §303(d) list as the starting point for the development of the 2000 §303(d) list. All waterbodies on the 1998 §303(d) list were evaluated for appropriate inclusion on the 2000 §303(d) list as defined in 40 CFR 130.2(j) and the August 27, 1997, EPA Guidance Memorandum, National Clarifying Guidance for State and Territory §303(d) Listing Decisions.

As outlined in 40 CFR 130.7(b)(6)(iv) and the National Clarifying Guidance, the Department prepared a list of "good cause" justification for the differences between the 1998 and the 2000 §303(d) lists. This compilation (which is attached) accounts for each waterbody that was included on the 1998 §303(d) list, but is not included on the 2000 §303(d) list. Good cause for delisting of waterbodies from the 2000 §303(d) list includes the following: 1) the stations indicating violations are located outside the boundaries of the State, 2) there was a change in analytical methodology of the data and information as prescribed in federal guidance, 3) the listing analysis conducted for the 1998 list contained errors, 4) the most recent data and information indicate that water quality standards are being met, and 5) a TMDL has been developed and approved. Any one or combination of these reasons may be used by the Department to delist waters.

Some waterbodies which were listed on the 1998 §303(d) list have been renamed or found to be in another watershed. These waterbodies appear on the 2000 §303(d) list under the new name or appropriate watershed.

Waterbodies that appeared on the 1998 §303(d) list which do not meet these justifications for good cause delisting must remain on the 2000 §303(d) list.

Waterbodies that are delisted for good cause are reviewed with the same methodology used for listing purposes with the exception that the Department does not use discretion when reviewing data and information. The Department retains the water on the State's 303(d) list until sufficient data and information exists that indicates water quality standards are being attained.

### 3. Methodology for Listing for the South Carolina 2000 §303(d) List

In accordance with federal guidelines, the Department evaluated waterbodies identified as impaired for appropriate inclusion on the 2000 §303(d) list. Details describing how water quality standards are assessed and evaluated are provided below. The Department uses a watershed approach, as encouraged in the August 8, 1997 EPA Guidance Memorandum: New Policies for Establishing and Implementing Total Maximum Daily Loads, to perform its permitting, water quality monitoring and data analysis. This approach divides the state into five river basin groups. Permitting, monitoring and data analysis are performed according to a schedule which cycles through all basins in five years. The Department has a fixed ambient surface water monitoring network throughout the State. These stations are sampled at a specified frequency every year. In addition to the fixed network, each year the Department activates additional stations in one basin. In accordance with the watershed cycle, more intensive water quality analysis is performed each year for a particular basin. Finally, permits are reissued every five years basin by basin.

The cyclical nature of our permitting, monitoring, and data analysis result in a dynamic §303(d) list. As new waters are monitored, new impaired sites may be found which require listing. As a result of increased monitoring and more specific federal guidance, some waterbodies have been added to the 2000 §303(d) list. In compliance with State water quality standards, waterbodies with violations which are attributable to natural conditions were not included on the South Carolina 2000 §303(d) list.

Also, in compliance with federal requirements for sources of information to be used for the development of the §303(d) list, the Department has considered the South Carolina Short List of waterbodies which was prepared pursuant to Section §304(l) of the CWA. This “one-time” §304(l) Short List identified waterbodies where the State did not expect applicable water quality standards to be achieved after technology-based requirements had been met due entirely or substantially to point source discharges of §307(a) toxics. The §304(l) Short List was considered as required, but not used for development of the 2000 §303(d) list since Individual Control Strategies were developed by the Department for each of the waterbodies included on the §304(l) Short List in 1989. These strategies allowed for the achievement of water quality standards through the reduction of the discharge of toxic pollutants from the associated point sources and no further action was required compliant with §304(l). Of course, if current data and information on water quality for the specific waterbodies included on the 1989 §304(l) list indicated less than full support of the uses of those waterbodies, they are included on the 2000 §303(d) list.

#### **Sources of Data and Information and Their Use**

Multiple sources of information were used to compile the South Carolina 2000 §303(d) list of waterbodies. The Department reviewed readily available data and information collected by the Department as well as from other sources, including that received after solicitation. For the 2000 §303(d) list, the Department considered additional chemical, biological, and tissue data and information that had been provided to the Department by the following:

In order to ensure the validity and accuracy of data and information used, the Department developed an evaluation plan. The Department's Quality Assurance Management Plan (QAMP) has been approved by the EPA as part of its requirements under Section 106 of the CWA. All data and information sources used for the 2000 §303(d) list were reviewed in accordance with the QAMP. All data and information were readily accessible and met the Department's criteria for comparable quality assurance. A copy of the QAMP may be obtained from the Department upon request.

The following is a brief description of how the above data and information are used by the Department to make use support determinations for both aquatic life and human health protection.

**Aquatic Life Use Protection**

Water chemistry, lake water quality assessments, and stream macroinvertebrate data were evaluated to prepare the South Carolina 2000 §305(b) Report and the Department's Watershed Water Quality Assessments. Those waterbodies for which ambient water quality data indicate less than full support of the classified uses were

considered for inclusion on the §303(d) list. Support of aquatic life use is based on the percentage of standard excursions of numeric water quality criteria, an interpretation of narrative water quality standards and criteria and, where data are available, the composition and functional integrity of the biological community.

#### *Water chemistry data*

An important goal of the State water quality standards is to maintain the quality of surface waters in order to provide for the survival and propagation of a balanced indigenous aquatic community of fauna and flora. The degree to which aquatic life is protected (aquatic life use support) is assessed by comparing important water quality characteristics and the concentrations of potentially toxic pollutants with numeric standards.

A dissolved oxygen (DO) criterion of 4 mg/l is used for Class SB, 6 mg/l for Trout Natural (TN) and Trout Put, Grow, and Take (TPGT), and 5 mg/l for all other Classes. An excursion is an occurrence of a DO concentration less than the stated criterion. For pH, there are several acceptable ranges applied depending on the Class of water: 6-8 SU (standard unit) for TPGT; 6-8.5 SU for Freshwaters (FW); 5-8.5 SU for FW\* (please refer to the water quality standards regulation for site specific); and 6.5-8.5 for Shellfish Harvesting (SFH), SA, and SB. For DO and pH, if 10 percent or less of the samples contravene the appropriate standard, then the standards are said to be fully supported. A percentage of standards excursions between 11-25 is considered partial support of the standard, and a percentage greater than 25 is considered to represent nonsupport of the standard, unless excursions are due to natural conditions pursuant to R.61-68.C.6.

If the acute aquatic life standard is exceeded for any individual toxicant (heavy metals, priority pollutants, chlorine, ammonia) in more than 10 percent of the samples, based on at least 10 samples, the standard is not supported. If the acute aquatic life standard is exceeded more than once, but in less than or equal to 10 percent of the samples, the standard is partially supported. If fewer than 10 samples were collected, discretion was used and other factors considered, such as the magnitude of the excursions or number of toxicants with excursions.

If the conclusion for any single parameter is that the standard is not supported, then it is concluded that aquatic life uses are not supported. If the conclusion for any single parameter is that the standard is partially supported, then it is concluded that aquatic life uses are partially supported. Biological data are the ultimate deciding factor for aquatic life uses, regardless of chemical conditions. The goal of the standards is the protection of a balanced indigenous aquatic community.

#### *Macroinvertebrate Data*

Macroinvertebrate community assessments are used, where available, to supplement or verify aquatic life use support determinations and to evaluate potential impacts from the presence of sediment contaminants. Aquatic and semi-aquatic macroinvertebrates are identified to the lowest practical taxonomic level depending on the condition and maturity of specimens collected. The EPT Index and the North Carolina Biotic Index are the main indices used in analyzing macroinvertebrate data. To a lesser extent taxa richness and sometimes total abundance may be used to help interpret data.

The EPT Index is a tabulation of taxa richness within the generally pollution sensitive groups. EPT values are compared with least impacted regional sites. The Biotic Index for a sample is the average pollution tolerance of all organisms collected, based on assigned taxonomic tolerance values.

Taxa richness is the number of distinct taxa collected and is the simplest measure of diversity. High taxa richness is generally associated with high water quality. Increasing levels of pollution progressively eliminate the more sensitive taxa, resulting in lower taxa richness. Total abundance is the enumeration of all macroinvertebrates

collected at a sampling location. This is generally not regarded as a qualitative metric. However, when gross differences in abundance occur between stations, this metric may be considered as a potential indicator.

#### *Lake Water Quality Assessments*

The Department also considered lake water quality assessment data that were used to prepare the 2000 §305(b) Report. The trophic condition of South Carolina lakes is monitored through the Department's network of routine sampling stations. Lakes with evidence of a degraded trophic condition, such as high chlorophyll *a* concentrations, are considered for inclusion on the §303(d) list. Historical nutrient data, information, and concerns are also considered. Watershed phosphorus control is needed to improve the condition of lakes listed for impairment by phosphorus.

### **Human Health Use Protection**

Another equally important goal of the South Carolina water quality standards is the protection of the public health and welfare. Whether for recreational uses in and on the waters of the State or by consuming water, fish, and shellfish, the Department evaluates the water quality to determine if these uses are supported. Bacteriological, fish tissue, and shellfish harvesting data were evaluated to prepare the South Carolina 2000 §305(b) Report.

### **Recreational Use Support**

#### *Bacteriological data*

The degree to which the swimmable goal of the CWA is attained (recreational use support) is based on the frequency of fecal coliform bacteria excursions, defined as greater than 400/100 ml for all surface water classes. If 10 percent or less of the samples are greater than 400/100 ml then recreational uses are said to be fully supported. A percentage of standards excursions between 11-25 percent is considered partial support of recreational uses, and greater than 25 percent is considered to represent nonsupport of recreational uses.

### **Consumption Use Support**

#### *Fish and shellfish tissue data*

The Department uses a risk-based approach to evaluate contaminant concentrations in fish tissue and to issue consumption advisories in affected waterbodies. This approach contrasts the average daily exposure dose to the reference dose (RfD). Using these relationships, fish tissue data are interpreted by determining the consumption rates that would not be likely to pose a health threat to adult males and nonpregnant adult females. Because an acceptable RfD for developmental neurotoxicity has not been developed and because scientific studies suggest that exposure before birth may have adverse effects on the health of infants, pregnant women and children are advised to avoid consumption of fish from any waterbody where an advisory has been issued.

The Department uses fish tissue data for issuance of Fish Consumption Advisories. The Department reviews data for toxics including mercury and polychlorinated biphenyls (PCBs). Issuance of a fish consumption advisory for a waterbody constitutes impairment of that waterbody and placement on the §303(d) list.

*Shellfish harvesting data*

Shellfish harvesting data were evaluated to prepare the 2000 §305(b) Report. Those waterbodies which are classified for shellfish harvesting but which are restricted to shellfish harvesting due to existing water quality standards violations were placed on the §303(d) list. Administrative closures are prohibited areas established adjacent to all point sources and/or marinas as a precaution to protect public health. These prohibited areas do not necessarily have lower water quality; such closures are required under South Carolina Regulation 61-47, *Shellfish*. These areas are not included as impaired since State water quality standards allow for these areas.

**4. Methodology for Priority Ranking**

The Department utilized a point system for prioritizing the waterbodies on the South Carolina §303(d) list for aquatic life and human health use impairment. This approach is based on an evaluation of data and information by the watershed managers and other staff within the Department. This process ranks waterbodies based on the severity of the water quality impairment and the impaired use of the waterbody. The process involves an evaluation of each water body for all of the following factors: potential impacts to endangered species, the severity of the pollution, the uses of the waterbodies, public support and, for waterbodies impaired by fecal coliform bacteria, the potential for primary contact recreation (swimming). Staff assigned numeric values for each factor. Points were totaled separately for each pollutant listed at a site. Based on the total numeric score, each impaired waterbody was given a priority ranking of 1, 2, or 3.

- ▶ Aquatic Endangered Species:
  - Species present and potentially adversely affected by pollutant (2 points)
- ▶ Severity of Pollution:
  - Nonsupport of classified use (2 points)
- ▶ Classification:
  - Outstanding Resource Waters (ORW) or TN (2 points)
  - TPGT, TPT, or SFH (1 point)
- ▶ Public Support:
  - High (2 points)
  - Some (1 point)
- ▶ Likely Primary Contact Recreational Use (for impairment by fecal coliform bacteria):
  - Yes (1 point)
  - No / Unknown (no points)

Waterbodies listed for fish consumption were assigned a priority ranking based on the extent and coverage of the advisory. Waterbodies listed for shellfish consumption were assigned a priority ranking based on recommendations of the Shellfish Restoration Committee.

**5. Methodology for Targeting Impaired Waterbodies for TMDL Development**

The §303(d) list of waterbodies serves to identify those waterbodies which need additional management actions. Targeting for TMDL development of the priority ranked waterbodies is necessary to focus limited technical and monetary resources. TMDLs targeted for completion over the next two years were based on the following factors:

- ▲ Priority ranking in the §303(d) list
- ▲ Adequacy of existing and readily available data and information for TMDL development
- ▲ Adequacy of existing technical tools for TMDL development



- ▲ Hydrologic connection, allowing “nesting” or “bundling” of TMDLs
- ▲ Identified funding or cooperators
- ▲ Degree of public interest and support
- ▲ Ongoing activities and water quality related initiatives in the watershed
- ▲ Recreational, economic, and aesthetic importance
- ▲ Other national and Departmental priorities and policies

The South Carolina 2000 §303(d) list is the first attachment. Waterbodies are listed by point locations; however, the impairment extends for some distance upstream and/or downstream of the point location listed. The Department will determine the extent of the impairment of the waterbodies during TMDL development.

Waterbodies targeted for completion in the next two years are noted by an asterisk (\*) on the list.

The column headings included on the South Carolina 2000 §303(d) list refer to the following:

**Waterbody** - Waters of the State.

**Impaired Site** - This column is a brief description of the location of the impaired waterbodies.

**Station Number** - This column refers to the Department's station code where data was collected for the cause of impairment for the waterbody.

**Basin** - This column refers to one of five basins that are contained in the State.

**County** - Name of county location of waters of the State.

**Hydrologic Unit** - The number in this column refers to a standardized subbasin unit in which the waterbody is located.

**Impaired Use** - This column refers to the use support impairment for aquatic life and/or recreational uses. Shellfish harvesting and fish consumption are subsets of recreational use support. The impaired uses are denoted as follows:

Recreational Use (Swimming):	REC
Fish Consumption:	FSH CON
Shellfish Harvesting:	SFH
Aquatic Life Use:	AL

**Cause** - This column refers to the problem parameter(s) that resulted in nonsupport or partial support of the uses listed. The parameters are denoted as follows:

Contaminated Crab & Shrimp Tissue: TIS	Mercury: HG
Contaminated Sediments: SED	Pesticides: PEST

**Priority** - Ranking on the §303(d) list.

**Area Description** - This column refers to the shellfish harvesting area where data were collected for the cause of impairment for the waterbody.

**Acres** - The number in this column refers to the acreage of impaired shellfish harvesting waters associated with the site.
