Dear Mr. Aycock,

The Underground Storage Tank (UST) Management Division of the South Carolina Department of Health and Environmental Control (Agency) has reviewed and approves the referenced document. However, the Agency requests that neither the Biosparging System nor the Aeration Bubblers in Brown's Creek be started prior to March 1, 2017, or until the joint sampling event has been conducted. The joint sampling event to sample and analyze surface water from Broadway Lake and its tributaries is scheduled to be conducted on February 28, 2017. It is further requested that testing on the Biosparging System or the Aeration Bubblers in Brown's Creek not be conducted in the area of the Brown's Creek Surface Water Protection Zone or Cupboard Creek Surface Water Protection Zone prior to March 1, 2017, or until the joint sampling event has been conducted.

As discussed with Scott Powell, with ch2m, an updated site specific Quality Assurance Program Plan or a site specific Sampling and Analysis Plan will need to be provided. The revised plan should be provided when the Addendum to the Corrective Action Plan is submitted, within 30 days of January 31, 2017.

Documents should continue to be provided in paper format and pdf via a disk with Site ID # 18693 and Plantation Pipe Line Lewis Drive Release noted in a prominent location.
