Use 2 templates when you need to report TC+ and/or EC+ samples.

The first template will be all the RTOR, Routine Original, samples and should be “Certified/Submitted” through CMDP. After submitting the first template of RTOR-Routine Originals, proceed with the submission of the REPEATS.

The second template will be all the REPEATS, **RPOR-Repeat Original**, **RPUP-Repeat Upstream**, and **RPDN-Repeat Downstream**. The second template with the REPEATS will require that the Original Sample ID, Original Reporting Lab ID, and the Original Collection Date data be included. This allows the REPEATS to be associated to the original sample that was TC+ and/or EC+.
