Minutes of the March 9, 2017 meeting of the South Carolina Board of Health and Environmental Control

The South Carolina Board of Health and Environmental Control met on Thursday, March 9, 2017, at 10:00 a.m. in the Board Room of the South Carolina Department of Health and Environmental Control, 2600 Bull Street, Columbia, South Carolina. (Attachment 0-1)

Vice-chair Ann Kirol called the meeting to order and stated notice of this meeting had been provided to all persons, organizations and news media, which have requested notification, as required by Section 30-4-80(e) of the South Carolina Code of Laws.

Item 1: Minutes of January 5, 2017 and January 13, 2017 meetings (Attachment 1-1)

Mr. Wells moved, seconded by Mr. Joye, to approve the minutes as presented for the January 5 and February 13, Board meetings. The Board voted and Motion carried.

Item 2: Administrative and Consent Orders issued by Environmental Affairs (Attachment 2-1)

Ms. Myra Reece, Deputy Director of Environmental Affairs, stated five (5) Administrative Orders and one hundred ninety (190) Consent Orders had been issued with total penalties of \$466,581.

The Board accepted this item as information.

<u>Item 3: Administrative Orders, Consent Orders and Sanction Letters issued by Health Regulation</u> (Attachment 3-1)

Mr. Thomas Bowen, Senior Consultant, Health Regulation Policy and Communications, stated three (3) Administrative Orders, five (5) Consent Orders, three (3) Emergency Suspension Orders, and one (1) License Renewal Denial had been issued with total penalties of \$12,600.

The Board accepted this item as information.

Item 4: Public Hearing - Wave Dissipation System (Attachment 4-1)

Vice Chair Kirol announced the start of the public hearing and introduced Ms. Jacquelyn Dickman, Legal Counsel to Board, who introduced the matter and provided guidelines for conducting the public hearing.

After discussion, Mr. Wells moved, seconded by Mr. Joye, to go into Executive Session for the purpose of obtaining legal advice on this matter. The Board voted and Motion carried.

After further discussion, *Mr. Joye moved, seconded by Mr. Wells, to allow the pilot study to continue with refined parameters and scope for a one year period so that a study will be completed for four seasons. The Board voted and Motion carried unanimously.*
