Minutes of the May 27, 2020, meeting of the South Carolina Board of Health and Environmental Control

The South Carolina Board of Health and Environmental Control met on Wednesday, May 27, 2020, at 4:45 p.m. in the Boardroom (#3420) at the South Carolina Department of Health and Environmental Control, 2600 Bull Street, Columbia, South Carolina. (Attachment 0-1)

Chairman Elam called the meeting to order and stated notice of this meeting had been provided to all persons, organizations and news media, which have requested notification, as required by Section 30-4-80(e) of the South Carolina Code of Laws.

Item 1: Employment and appointment of an employee

Upon introduction of the matter by the Chairman, Mr. Creel made a motion that the Board go into Executive Session pursuant to SC Code Section 30-4-70(A)(1) to discuss an employment matter. Ms. Shrivastava-Patel seconded the motion and the motion carried unanimously.

Chairman Elam stated the Board was back in public session and while in Executive Session no actions were taken.

Chairman Elam recognized Director Toomey. Director Toomey addressed the Board, made a brief statement, and informed them that on May 24, 2020, he has met with Chairman Elam and verbally informed him of the decision to resign as Director of the South Carolina

Department of Health and Environmental Control effective June 10, 2020. The Board expressed their appreciation for all Director Toomey has done for the Agency.

Mr. Creel moved, seconded by Mr. Joye, to accept Director Toomey's resignation and to appoint Marshall Taylor as Acting Director to serve from June 11, 2020, until a new Director is appointed by the Board, approved by the Governor, and confirmed by the Senate. The Board voted and the Motion carried.

Being no further business, the Chairman adjourned the meeting.
